

How Will You Keep the Holidays Green? Facebook Contest

Take Care of Texas Contest Rules

- Only one entry per person. Anyone found using multiple accounts to enter will be ineligible.
- Entrants must be 18 years of age or older and a legal U.S. resident.
- Current employees and their immediate families (spouses, parents, siblings, children, and each of the respective spouses or people living in the same household of each) of the Texas Commission on Environmental Quality (TCEQ) or H-E-B are not eligible to participate.
- To be eligible for the drawing, each entry must make a comment under our Facebook post of how the entrant is going to keep the holidays “green”.
- All entries must be received by 11:59 p.m. on December 14, 2021. Late entries will not be accepted. The winning entry will be randomly drawn December 15, 2021. We will attempt to notify the winner the same day by
 - tagging or commenting directly under the entry on Facebook
 - replying via direct message on Facebook
- If we cannot connect with the winner directly by 5 p.m. on December 16, 2021, another entry will be drawn.
- Winners will be chosen by the following method: All qualifying entries will be exported into a numbered database. Each entry will be assigned a number according to the order in which it was received. Take Care of Texas will use the app R.N.G “Random Number Generator” to choose one number at random. The entry matching the number chosen will be determined as the winner. Odds of winning are dependent on the amount of entries received.
- Prize includes one \$100 H-E-B gift card. Prizes are non-transferable.
